**ASSAULT**

Burning Tree Court, 8/18, 1:10 a.m. Deputy S. Waheed responded to an assault. It was discovered during a sleepover an eighteen-year-old assaulted a juvenile after inappropriate comments were made. The suspect would then brandish a knife and demand everyone to leave the residence. The suspect was charged with strangulation, as well as, assault and battery. He was held at Rappahannock Regional Jail on a \$10,000 secured bond.

**DUI**

Intersection of Garrisonville Road and Dorothy Lane, 8/18, 7:23 p.m. First Sergeant D.W. Fetterolf was traveling on Garrisonville Road when he encountered a red light. Like most citizens, he stopped at the red light; however, moments later a Chevy Tahoe passed him and went through the red light. First Sergeant Fetterolf conducted a traffic stop as Deputy J.J. Holetzky responded to assist. The driver had signs of intoxication, admitted to consuming "a beer," and sitting right next to him was an open can of beer. The driver was charged with driving under the influence, drinking while driving, failure to obey a traffic light, and second offense refusal. He was held at Rappahannock Regional Jail on a \$5,000 secured bond.

### **PUBLIC INTOXICATION**

Fitness 1440, 570 Celebrate Parkway, 8/19, 5:53 p.m. Deputy D.S. Jett responded to an out of this world call. The caller advised there was a male in the parking lot who appeared “stressed” and acting like he was being arrested. Deputy Jett made contact with the suspect, who advised he took cocaine that transported him to “another planet.” The suspect further advised he had a hallucination earlier in which he took drugs and deputies arrested him. After being given consent to search the suspect’s vehicle, deputies fulfilled that prophecy after locating suspected controlled substances. The suspect was charged with public intoxication, possession of controlled substances, and possession of paraphernalia. He was held at Rappahannock Regional Jail until sober.
