ASSAULT

McDonald's, 893 Garrisonville Road, 8/23, 2:30 p.m. Deputy T.S. Myree responded to an assault. The juvenile victim advised he was enjoying a very happy meal when an unknown female demanded he "get up and move." Since there was no assigned seating, the victim refused and in response, the suspect assaulted him. The suspect was discovered to be intoxicated and had a small box of wine in her possession. She was charged with assault and battery, as well as, public intoxication. She was held at Rappahannock Regional Jail without bond.

BREAKING AND ENTERING

True Road, 8/24, 3:52 p.m. Deputies responded to a breaking and entering. The victim advised she went downstairs to do laundry when she observed an unknown male in her residence. The suspect was described as a black male wearing all black and a ski mask, approximately six feet tall, weighing 230 pounds with scruffy facial hair. It was discovered the suspect stole multiple items of food. Detectives are still investigating and if anyone has any information they are asked to contact the Sheriff's Office at 540-658-4450.

DUI

2800 block of Richmond Highway, 8/23, 12:25 a.m. Deputy S. Waheed responded to a drunk driver complaint. The caller advised a Nissan was swerving. Deputy Waheed would observe the speeding swerving suspect and conducted a traffic stop. The driver had signs of intoxication and advised he consumed "one bottle" of wine prior to driving. He would later change his answer to a smaller magnitude, claiming only "one glass." One glass or one bottle, the suspect was still driving intoxicated. He was charged with driving under the influence and failure to maintain the lane of travel. He was held at Rappahannock Regional Jail until sober.

Wawa, 3099 Richmond Highway, 8/23, 1:30 p.m. Deputy C.S. Harding responded to a drunk driver complaint. The caller advised a Nissan was swerving. Either Nissan has a lot of explaining to do or this was yet another drunk driver. Deputy Harding made contact with the driver, who had very noticeable signs of intoxication. Within her vehicle were numerous empty bottles of alcohol

from a wide range of different brands. The driver was charged with driving under the influence and held at Rappahannock Regional Jail until sober.

Intersection of Kings Highway and Cool Springs Road, 8/23, 5:56 p.m. Deputy W.E. Trainor responded to a drunk driver complaint. To switch things up, this time it was advised the driver of a Chevy was intoxicated. Deputy Trainor made contact with the driver who had signs of intoxication, admitted to consuming “three beers” prior to driving, and had two children within the vehicle. He was charged with driving under the influence with a child present. He was held at Rappahannock Regional Jail until sober.

Potomac Hills Fire Station, 8/24, 12:47 a.m. First Sergeant M.R. Flick observed a Toyota traveling 65 MPH in a 45 MPH zone failing to maintain the lane of travel. First Sergeant Flick conducted a traffic stop as Deputy J.J. Suh responded to assist. Deputies made contact with the driver, who’s first statement was “I’m in trouble.” He was correct considering the “two drinks” he had prior to driving. The driver was charged with driving under the influence with a blood alcohol content between .15 and .2, reckless driving, and failure to maintain the lane of travel. He was held at Rappahannock Regional Jail until sober.

Duff Green Park, 75 James Ashby Parkway, 8/24, 3:04 p.m. Deputy F.A. Martinez responded to multiple vehicle break ins. Three vehicles were broken into and numerous items were taken, including credit cards. We encourage residents to remove valuables from their unattended vehicles.

WARRANT SERVED

Tacketts Mill Road, 8/23, 10:08 p.m. Deputy C.M. Sterne responded to a warrant service. The suspect was wanted out of Stafford County for credit card theft, as well as, credit card fraud. Deputy Sterne made contact with the suspect and informed her of the charges. A family member would interject herself into not only the conversation, but would physically stand between Deputy Sterne and the suspect. The wanted suspect would attempt to retreat within the residence as the family member blocked Deputy Sterne from detaining her. Despite the interruption, the wanted suspect was detained. The wanted suspect was served on her outstanding warrants and was released by the magistrate on personal recognizance. The family member was issued a summons for obstruction of justice.
