BREAKING AND ENTERING

Windsor Ridge Court, 8/2, 2:06 p.m. Deputy J.E. Cordes responded to a breaking and entering. The victim advised he returned home from the gym to discover his front door to have signs of forced entry. After an inventory of the home was conducted, it was discovered approximately \$9,000 worth of items were stolen from the residence. The investigation is ongoing.

DUI

Deacon Road, 8/3, 1:26 a.m. Sergeant E.E. West was in the area when she observed a speeding vehicle tailgating another vehicle with its trunk open. For obvious reasons, she conducted a traffic stop and made contact with the driver, who had signs of intoxication. When "one beer" changed to "a few" and eventually to "a couple beers," field sobriety tests were conducted. The driver was charged with driving under the influence with a blood alcohol content between .15 and .2, drinking while driving, driving without a license, and following too closely. He was held at Rappahannock Regional Jail on a \$2,000 secured bond.

LARCENY

Willow Branch Court, 8/2, 1:28 p.m. Sergeant M.E. Gordon responded to a larceny. The victim had her purse stolen from her unattended vehicle.

Kohl's, 1220 Stafford Market Place, 8/2, 9:00 p.m. Deputy C.A. Osborne responded to a larceny. Staff had video of a female suspect entering the store and stealing items. She would exit the store, put the stolen items in a white SUV before entering the business again to repeat the process. Her double or nothing shoplifting spree left the business with 188 items missing.

PUBLIC INTOXICATION

Holiday Inn Express, 594 Warrenton Road, 8/2, 12:15 p.m. Deputy K.W. Suter was flagged down in the parking lot for a disagreement. While being the mediator, Deputy Suter observed signs of intoxication coming from the male party. He was charged with public intoxication and held at Rappahannock Regional Jail until sober.

The pint of vodka in his possession was a third full, or two thirds empty depending on how you look at it. He was once again charged with public intoxication and held at Rappahannock Regional Jail until sober.

THREATS

Firebrick Drive, 8/3, 9:18 a.m. Deputy C.D. Sullivan responded to a disturbance. It was advised a male party at the residence was under the influence and making threats to burn down the victim's house and church she attends. Deputies made contact with the suspect, who was less than cooperative, and resisted arrest. He was charged with threats to burn a building and obstruction of justice. He was held at Rappahannock Regional Jail without bond.
