### **BREAKING AND ENTERING**

Lakeview Drive, 8/7, 12:00 p.m. Deputy C.D. Sullivan responded to a breaking and entering. The caller advised he observed a neighbor's door broken. Within the residence Deputy Sullivan observed illegible writing in spray paint.

### DUI

Mountains View Market, 1259 Mountain View Road, 8/7, 6:50 p.m. Deputy R.L. Hubbard and Deputy V.R. Weadon responded to a drunk driver complaint. The caller advised he was witnessing "the worst driving I've ever seen," as a green truck was failing to maintain the lane of travel. Deputies would also observe the less than ideal driving and made contact with the driver. The driver had signs of intoxication, admitted to consuming alcohol prior to driving, an open Modelo beer in the center console, and no driver's license. Despite the clear infractions, the driver instated he was "okay," and could get home. Deputies determined otherwise. He was charged with driving under the influence, drinking while driving, driving without a license, and the traffic lane violation. He was held at Rappahannock Regional Jail without bond.

Fulton Drive, 8/7, 11:00 p.m. Deputy S. Waheed responded to a suspicious vehicle report. The caller advised a vehicle parked there moments ago but no one was getting out. When Deputy Waheed arrived, he discovered the vehicle was parked in a fire lane and made contact with the driver. The driver had signs of intoxication and admitted to consuming "a little bit" before she got behind the wheel. A little too much would have been a more appropriate response for she was charged with driving under the influence and held at Rappahannock Regional Jail until sober.

#### FRAUD

Public Safety Building, 1225 Courthouse Road, 8/7, 7:30 p.m. Deputy D.A. Robertson made contact with a victim of a fraud in the lobby. It was advised the victim was contacted by someone posing as a security company inquiring about potential fraudulent activity. After conversing with the individual, it was discovered money was fraudulently withdrawn from her bank and she was now locked out of her account.

While arriving on scene, Deputy Bierfeldt observed the suspect stumbling and nearly fall into traffic. The suspect advised he was headed to his girlfriend's house, despite her house being Southbound and he was traveling Northbound. The suspect had obvious signs of intoxication. He would have to wait a bit longer to see his girlfriend for he was charged with public intoxication and held at Rappahannock Regional Jail until sober.
