ASSAULT

Marriott Courtyard, 375 Corporate Drive, 7/20, 12:22 a.m. Deputy W.E. Trainor responded to an assault. It was discovered the suspect was in an intoxicated state while conversing with the victim. When the victim informed the suspect on a personal matter, the suspect did not take kindly to the news. She would assault and strangle the victim. The suspect was charged with public intoxication, assault and battery, as well as, strangulation. She was held at Rappahannock Regional Jail without bond.

DUI

Taylor's Hill Way, 7/20, 12:59 a.m. Deputy A.E. Epps responded to a drunk driver complaint. The caller advised a Jeep joyrider was intoxicated. Deputy Epps observed the vehicle traveling in the center of the roadway and made contact with the driver. The driver advised he had two beers during a Dirty Heads concert. This concert would have no encore for the driver was charged with driving under the influence second offense within five years. He was held at Rappahannock Regional Jail without bond.

WARRANT SERVED

Staff advised a suspect, known for stealing from the business, had returned. He was currently wanted out of both Stafford County and the city of Fredericksburg. During a search incident to arrest, deputies discovered something the suspect claimed was nothing but “random trash.” Sergeant West, being the Drug Recognition Expert she is, knew this trash was more likely a controlled substance. The suspect was served on his 13 outstanding offenses and held at Rappahannock Regional Jail without bond. Additional charges are pending.
