BREAKING AND ENTERING

Castlebury Court, 7/26, 10:41 p.m. Deputy J.J. Suh responded to an unwelcome guest. The victim advised while doing laundry she discovered an unknown male within her residence. While fleeing, the suspect would push the victim out of the way. The suspect was described as a thin black male, approximately 50 years in age wearing a black hoodie and jeans. There were no signs of forced entry and the suspect was not located.

DRUGS

Warrenton Road in the area of the Southbound I-95 exit ramp, 7/26, 7:54 p.m. Sergeant B.U. Demirci was traveling on Warrenton Road when he observed a vehicle with an expired inspection sticker.
