ASSAULT

Tobacco Hut, 44 Mine Road, 9/8, 4:46 p.m. Deputy R.W. Stamm responded to an assault. The victim advised an unknown male tried to start up a conversation with him. When the victim informed the suspect he wasn't interested in chatting, the suspect assaulted the victim.

DUI

Intersection of Warrenton Road and Village Parkway, 9/8, 5:10 a.m. Deputy S.A. Edwards responded to a single vehicle auto accident. It was discovered the vehicle went off the roadway, struck a tree stump and rolled over until it stopped. The driver had signs of intoxication and admitted to consuming alcohol prior to driving. He was transported to a nearby hospital to be treated for his injuries and was charged with driving under the influence.

LARCENY

The victim advised he went into the store to purchase items only to return to the parking lot to discover his vehicle was taken. The vehicle was entered as stolen into a law enforcement database. Later, the Winchester Police Department advised they located the stolen vehicle and detained the suspect involved. A warrant for grand larceny was obtained.

Using store cameras, it was discovered a female suspect stole the wallet. The victim would later receive notification of fraudulent activity on her credit cards.

PUBLIC INTOXICATION

Aquia Bay Avenue, 9/8, 5:32 a.m. Deputy J.A. Martin responded to a suspicious person report. The caller advised an unknown male wearing cowboy boots was on his porch. Deputy Martin made contact with this lone ranger, who advised he just left the “ranch” and had six beers. Deputy Martin saddled up and went on a quick mosey to Rappahannock Regional Jail with the 20-year-old. There, he was charged with public intoxication and underage consumption of alcohol.

Wakefield Avenue, 9/8, 7:45 p.m. Deputy I.E. Baldi responded to a disturbance. The caller advised an intoxicated male left his residence and was screaming. Deputy Baldi made contact with the screaming suspect, who had signs of intoxication and admitted to consuming “a few beers.” Whether he was attempting to cope with the Washington Commander’s loss or not, he was still publicly intoxicated and was subsequently arrested for that. He was held at Rappahannock Regional Jail until sober.

WARRANT SERVED

Boswell’s Corner, 9/9, 10:30 p.m. Deputy W.E. Trainor observed a vehicle speeding and conducted a traffic stop. During the traffic stop, Deputy Trainor discovered the vehicle had a fictitious license plate and the driver was wanted out of Texas for a felony warrant. She was charged with fugitive from justice, and possession of fictitious registration. She was held at Rappahannock Regional Jail on a \$6,000 secured bond.
