

# STAFFORD COUNTY SHERIFF'S OFFICE DAILY INCIDENT REPORT RELEASE DATE: SEPTEMBER 16, 2024

### **ASSAULT**

Mary Washington Hospital, 1001 Sam Perry Boulevard, 9/13, 10:44 a.m. A Mental Health Deputy was at the hospital for an unrelated matter when he observed an agitated male refusing the help of a nurse. When the deputy attempted to assist in the disagreement, the male assaulted the deputy. The deputy was not injured and the suspect was detained. A warrant for assault and battery on law enforcement was obtained.

Rappahannock Juvenile Detention Center, 275 Wyche Road, 9/13, 10:48 a.m. Deputy S.M. Craig responded to an assault. A teacher was assaulted by a juvenile after addressing discipline issues. A criminal complaint for assault and battery was filed.

Amazon, 220 Centreport Parkway, 9/13, 11:26 p.m. Deputy M.N. Sayegh responded to an assault. An employee assaulted another after not having the door held open for him. The suspect was issued a summons for assault and battery.

Circle K, 34 Prosperity Lane, 9/14, 8:10 a.m. Deputy C.D. Sullivan responded to an assault. It was advised a female suspect pushed multiple customers while in the check out line. Despite line cutting, the suspect would still walk out of the business with unpaid merchandise. She was charged with assault and battery, as well as, shoplifting. She was held at Rappahannock Regional Jail without bond.

#### **DUI**

Foxwood Drive, 9/13, 12:30 a.m. Deputy T.G. Croson was in the area when he observed a vehicle missing a tire. The driver of the three wheeled Jeep had signs of intoxication and admitted to consuming "a couple drinks" prior to driving. An open Corona was also located within the vehicle. The driver was charged with driving under the influence with a blood alcohol content between .15 and .2. He was held at Rappahannock Regional Jail on a \$2,500 secured bond.

Choptank Road, 9/13, 11:54 p.m. Deputy C.A. Osborne responded to a lover's quarrel between a new couple. The situation was deescalated when the female left the residence. Later into his shift,

Deputy Osborne would be informed the female had returned to the residence. It was discovered the female drove in an intoxicated state back to the residence. She was charged with driving under the influence and was released by the magistrate on personal recognizance.

Intersection of Mine Road and Alder Drive, 9/14, 2:05 a.m. Deputy K.F. Bierfeldt was traveling on Courthouse Road when the vehicle in front of her began accelerating to 61 MPH in a 40 MPH. Deputy Bierfeldt conducted a traffic stop and made contact with the driver. The driver had signs of intoxication; however, advised he consumed "not too much." After field sobriety tests were conducted, an inventory search of the vehicle was conducted where suspected controlled substances were located. He was charged with driving under the influence, reckless driving, refusal, and possession of controlled substances. He was held at Rappahannock Regional Jail on a \$5,000 secured bond.

Waffle House, 580 Warrenton Road, 9/14, 2:24 a.m. First Sergeant D.W. Fetterolf conducted a traffic stop on a vehicle as Deputy M.N. Sayegh responded to assist. The driver had signs of intoxication and a cup in the center console filled with "two or three shots." He was charged with driving under the influence and held at Rappahannock Regional Jail on a \$2,000 secured bond.

#### **LARCENY**

Wawa, 3099 Richmond Highway, 9/14, 11:33 p.m. Deputy W.E. Trainor responded to a larceny. Staff advised three female suspects stole four boxes of wine. They would then leave in a white Mazda SUV.

## **PUBLIC INTOXICATION**

Jay's Sports Lounge, 2866 Richmond Highway, 9/13, 1:06 a.m. Deputy J.A. Martin responded to a disturbance. The caller advised a known female was intoxicated and threatened to damage her vehicle. Deputy Martin made contact with the suspect next to the innocent vehicle and discovered she was in fact intoxicated. The suspect was charged with public intoxication and held at Rappahannock Regional Jail until sober.

Walmart, 14 North Stafford Complex, 9/15, 10:26 a.m. Deputy E.L. Shelton, Deputy F.C. O'Neill, and Deputy C.D. Sullivan responded to a disturbance. It was advised there was an altercation in the parking lot and one of the involved parties appeared intoxicated. Deputies made contact with the male suspect who had signs of intoxication and admitted to consuming alcohol. Deputies also made contact with a female suspect who was wanted out of Prince William County for two



warrants. During their interaction, she admitted to be in possession of a crack pipe. Deputies located the pipe in question along with another one and suspected controlled substances. The male was charged with public intoxication and held at Rappahannock Regional Jail until sober. The female was charged with possession of controlled substances, possession of paraphernalia, as well as, served on her outstanding warrants. She was held without bond.

Intersection of Richmond Highway and Garrisonville Road, 9/14, 10:03 p.m. Deputy R. Tully was in the area when he observed an intoxicated female on the side of the road. Deputy Tully knew she was intoxicated due to a prior interaction and attempted to detain her. She would begin cussing, refusing commands, and demanded an ambulance to give her a ride back to her vehicle. Instead of assisting in a DUI, Deputy Tully charged the suspect with public intoxication, disorderly conduct, and falsely summoning an ambulance. She was held at Rappahannock Regional Jail on a \$3,500 secured bond.

#### **THREATS**

Days Inn, 14 Simpson Road, 9/13, 8:35 p.m. Deputy M.N. Sayegh responded to a disturbance. The female victim advised she was texting a known male suspect when he requested they partake in personal relations. When she declined, the suspect threatened to shoot the victim's boyfriend. The suspect would arrive at the business and brandish a firearm. He would flee prior to deputies' arrival. On September 15<sup>th</sup>, the boyfriend would also report threats made directly to him. The investigation is ongoing.
