ASSAULT

Bellows Avenue, 8/31, 11:19 p.m. Deputy K.P. Hall responded to a disturbance. It was discovered a male suspect assaulted his girlfriend and brandished a firearm twice towards two of her friends. Warrants for four counts of brandishing a firearm and one count of assault and battery were obtained but not yet served.

DUI

Murphy Express, 450 Kings Highway, 8/30, 8:03 p.m. Deputy M.A. Pearce was traveling Eastbound on Kings Highway when he observed a vehicle with no tail lights failing to maintain the lane of travel and making questionable driving decisions. Deputy Pearce conducted a traffic stop as Deputy A.E. Epps responded to assist. The driver had signs of intoxication and admitted to consuming multiple cocktails at home before getting behind the wheel. He was charged with driving under the influence and held at Rappahannock Regional Jail until sober.

3000 block of Warrenton Road, 8/31, 2:40 a.m. Deputy S.T. Myers was traveling in the area when he observed a motorcycle traveling at speeds just under 100 MPH. Deputy Myers conducted a traffic stop as Deputy K.P. Hall responded to assist. The driver had signs of intoxication and admitted to doubling his alcohol intake by having two beers and two shots at a local bar. During their interaction, deputies learned the suspect was carrying a concealed firearm, knife, and brass knuckles without a valid concealed weapons permit. He was charged with driving under the influence, carrying a concealed weapon, and speeding. He was held at Rappahannock Regional Jail until sober.

Intersection of Richmond Highway and Centreport Parkway, 8/31, 3:48 a.m. Deputy M.N. Sayegh was traveling in the area when she observed two vehicles parked in a travel lane. Deputy Sayegh made contact with both drivers as Deputy E.T. Osborn responded to assist. It was discovered the first driver struck a curb and disabled her vehicle. She would then call the second driver to assist her. As noble as his actions were, it was discovered the second driver was under the influence. He would admit to consuming "a couple" Beat Boxes prior to driving. He was charged with driving under the influence and held at Rappahannock Regional Jail until sober.

Deputy Tully conducted a traffic stop and made contact with the driver, who not only had multiple traffic related offenses, but had signs of intoxication. He was charged with driving under the influence, driving without insurance, driving a vehicle with an open title, driving without a license, having an expired registration, and having an expired state inspection. He was held at Rappahannock Regional Jail until sober.

FRAUD

Papa Johns, 2769 Richmond Highway, 8/30, 1:40 p.m. Deputy C.M. Ramirez responded to a report of someone trying to con papa out of pizzas. Staff advised a male suspect attempted to pay for his order with a poorly made counterfeit bill. When staff informed the suspect they knew the bill was fake, the suspect attempted to pay with three additional counterfeit bills. Again, his dough wasn't good enough for their dough.

LARCENY

Target, 25 South Gateway Drive, 8/30, 11:37 a.m. Deputy S.A. Hensley responded to a larceny. Staff advised a female just walked out with a child seat and was fleeing the area in a silver van. Deputy Hensley located the suspect vehicle just down the street at Wawa and made contact with the suspect. The suspect, still in possession of the child seat, attempted to use the excuse of diarrhea as a valid reason to commit the larceny. That did not work and she was issued a summons for shoplifting.

ABC, 50 North Stafford Complex Center, 8/30, 7:11 p.m. Deputy R. Tully responded to a larceny. Staff advised a male suspect requested to use the business's phone to call his mom. While he would return the phone, he wouldn't return the Crown Royal hidden in his jacket. At approximately 9:59 p.m. deputies responded to a public intoxication call and discovered the suspect was one in the same as the larceny suspect. Magically, the Crown Royal was gone and the suspect had signs of intoxication. He was charged with larceny, underage possession of alcohol, and public intoxication. He was held at Rappahannock Regional Jail until sober.

Decatur Road, 8/31, 11:58 a.m. Deputy S.M. Craig responded to a larceny. The victim advised her vehicle was broken into overnight and a number of items were taken, including a PlayStation 5, numerous high-priced shoes, and valuable hats.

WARRANT SERVED

Wawa, 860 Richmond Highway, 8/30, 9:57 a.m. Sergeant M.E. Gordon responded to a service request. The Fredericksburg Police Department had warrants for felony attempted malicious wounding, destruction of property, and aggressive driving to injure for a 32-year-old Stafford man. While Sergeant Gordon could not locate the suspect at his residence, she would observe him at the Wawa. With the assistance of Deputy J.W. McAlister and Fire Marshall D.M. Pappas the suspect was detained. In his possession were a number of stolen credit cards. The suspect was served on his outstanding warrants and additionally charged with four counts of credit card theft and larceny. He was held at Rappahannock Regional Jail without bond.
