

STAFFORD COUNTY SHERIFF'S OFFICE DAILY INCIDENT REPORT RELEASE DATE: SEPTEMBER 4, 2024

ASSAULT

Nobel Court, 9/2, 7:23 p.m. Deputy D.A. Robertson and Deputy C.R. Newman responded to an assault. Two females were engaged in a verbal argument when one of them began assaulting the other. In retaliation, a male and juvenile female began assaulting the predominant aggressor. The predominant aggressor was charged with assault and battery. She was released by the magistrate on personal recognizance. A warrant for assault by mob was obtained for the male, but has not yet been served. A criminal complaint for assault by mob was filed for the juvenile female.

FRAUD

Circle K, 34 Prosperity Lane, 9/2, 1:06 p.m. Deputy S.M. Eastman responded to a phony money report. Staff advised a male suspect attempted to pay with a counterfeit \$100 bill. Considering its poor quality, they refused his sale. As Deputy Eastman was leaving, he was informed of the same set of circumstances just occurred down the street at 7-Eleven, 378 Garrisonville Road. There, the suspect tried to pay with a poorly made counterfeit bill and was refused. The suspect was described as a black male with dreads driving a small black sedan.

LARCENY

Ulta, 1150 Stafford Market Place, 9/3, 3:20 p.m. R.W. Stamm responded to a larceny. Staff advised a larceny occurred the day prior where a female suspect stole over \$3,600 worth of items.

Kohl's, 1220 Stafford Market Place, 9/3, 6:26 p.m. Deputy B.E. Vaughn responded to a larceny. Staff advised a male suspect stole nearly \$680 worth of items. Deputy Vaughn was able to identify the suspect and obtained a shoplifting warrant on him.

Target, 1090 Stafford Market Place, 9/3, 8:01 p.m. Deputy B.E. Vaughn responded to another larceny. Staff advised a male suspect stole over \$1,000 worth of items. Deputy Vaughn was able to easily identify the suspect considering he was the same suspect as the previous larceny. A warrant for felony shoplifting was obtained.

The 38-year-old had signs of intoxication and admitted to typically drinking 10 to 12 "regular beers." Considering this, and the fact most sober people don't roll around in the mud at three in the morning, he was arrested for public intoxication. He was held at Rappahannock Regional Jail until sober.

Intersection of Warrenton Road and Melchers Drive, 9/2, 7:53 p.m. Deputy S.A. Edwards responded to a public intoxication call. The caller advised a male wearing a sports jersey was stumbling on the side of the road. Deputy Edwards arrived in the area and observed the suspect stumbling much like a 49ers' linebacker. The suspect had signs of intoxication and was arrested for public intoxication. He was held at Rappahannock Regional Jail until sober.

Quarles, 291 Warrenton Road, 9/2, 8:42 p.m. Deputy D.S. Jett was pumping gas when he observed a stumbling suspect. Deputy Jett made contact with the suspect who had signs of intoxication and admitted to drinking six beers.
